## **Boundary adjustment**

Where the building work is proposed on land that is in the process of boundary adjustment under a subdivision application and lots are owned by different owners, building consent applications will be accepted for processing only when the plan deposit notice is provided with the building consent application.

## New Lots being created

Where the building work is proposed on land that is in the process of being subdivided, building consent applications will be accepted for processing only when the S224 certificate under the Resource Management Act 1991 is issued by NPDC, and sewer, water and stormwater services are not bonded, and the following documents are provided with the building consent application:

- 1. Copy of S224 certificate, and
- 2. Copy of land transfer plan and S223 certificate endorsed, and
- 3. Site plan based on the approved subdivision plan, instead of the parent property, and
- 4. Copy of relevant portion of the sale and purchase agreement (the page where the names of the seller and buyer and the site that was sold are stated), and
- 5. Copy of consent notice, if applicable, and
- 6. Copy of as-built certifying the location of the sewer and water/stormwater connections/easements to the site and the location of the street furniture (including trees and sumps) relative to proposed vehicle access.

## NPDC discretion in certain circumstances

If the subdivision has not yet received an S224 certificate under the Resource Management Act 1991, an application for a building consent may be accepted for processing only if the following documents are provided:

- Certificate from a licensed surveyor or suitably qualified engineer stating that the subdivision has progressed to the point that all geotechnical requirements (including earthworks), infrastructure requirements (including sewage, water and stormwater), and roading and traffic requirements conditions that are part of the subdivision are known and solutions have been incorporated to the building consent application, and
- 2. A report from a suitably qualified person on the suitability of the ground, and
- 3. Copy of land transfer plan and S223 certificate endorsed, and
- 4. Site plan based on the approved subdivision plan, instead of the parent property, and
- 5. Copy of relevant portion of the sale and purchase agreement (the page where the names of the seller and buyer and the site that was sold are stated), and
- 6. Copy of as-built certifying the location of the sewer and water/stormwater connections/easements to the site and the location of the street furniture (including trees and sumps) relative to proposed vehicle access.

## Indemnity

The owner/applicant accepts that the issue of a building consent as requested by an application does not provide any assurance or representation by New Plymouth District Council that legal title to the land is now or will ever become available and the owner/applicant should take legal advice before commencing any construction work.

## Exemptions

Project information memorandum (PIM) applications may be lodged at any time.

If your building project is limited to any of the following projects, building consent applications may be lodged at any time:

- a) Plumbing and drainage only.
- b) Internal alterations.
- c) Demolition.
- d) Removal.
- e) Conversion of an existing dwelling into flats.
- f) Accessory and minor farm buildings.
- g) Retaining walls.
